BRESCIA, ITALY, MARCH 30-APRIL 2, 2023

dèdalo ensemble is proud to announce the 4rd Competition Città di Brescia, dedicated to the memory of the late composer and conductor Giancarlo Facchinetti (1936-2017). The competition is open to conductors of any nationality with no age limit and is dedicated to the modern and contemporary repertoire for ensemble.

The competition will be held in **Brescia from March 30 till April 2, 2023**, Auditorium San Barnaba (March 30,31 First round, April 1 Semifinal, April 2 final and Concert)

The prize concerts will be held in Poland, Czech Republic, Romania and Italy.

RULES

The competition is divided in 3 steps: First round, Semifinal, Final.

The competition is open to conductors of any nationality with no age limit. The winners of the First prize of the previous editions cannot be accepted in the competition.

Application deadline: February 19, 2023 by e-mail sent to concorso@dedaloensemble.it

Candidates must send a detailed bio, personal data and nationality included. Candidates must send links to videos of their conducting with orchestras or ensembles of any repertoire. Piano solo videos cannot be accepted. In these videos candidates have to be filmed with a frontal or lateral view.

The candidates admitted, no more than 38, will be informed within February 28, 2023. The names of admitted candidates and a waiting list will be published on website www.dedaloensemble.it and on the Facebook competition page

dèdalo ensemble Association has the right to postpone the Competition if the international Covid19 pandemic situation should be still very dangerous. The competition will follow the rules issued by the Italian Government on safety and distancing for all the people involved.

FIRST ROUND: The candidates admitted to the 1st Round will conduct excerpts decided by the Jury from:

A.COPLAND: Appalachian Spring Suite 1st version for chamber orchestra, Boosey & Hawkes Ed.

M.de Falla: El Amor Brujo Suite 1st version for chamber orchestra (1915), parts without singer only, Chester Ed.

Each candidate will conduct for no more than 15 minutes

SECOND ROUND: The candidates admitted to the Semifinal will be no more than 12 and they will conduct excerpts decided by the Jury from:

T. MURAIL: Feuilles à travers les cloches, Lemoine Ed.

P.DE GRAAFF: Pascal, Donemus Ed.

Each candidate will conduct for no more than 20 minutes.

FINAL: The candidates admitted to the Final will be no more than 3 and they will conduct excerpts decided by the Jury from:

- G. FACCHINETTI: Divertimento N° 2. The pdf score will be sent on request following the application
- **P. MAGNANINI**: Chamber work coming from the new chamber opera "Lei non sa chi sono io!". The pdf score will be available and sent by dèdalo ensemble starting from March 1, 2023
- A. SCHÖNBERG: Suite op 29 (version for flute, clarinet, bassoon, piano, violin, viola, cello), Universal Ed.

Each candidate will conduct for no more than 60 minutes

FINAL CONCERT: The 3 candidates selected for the Final will conduct the works selected by the Jury integrally or partially.

The prize giving will follow the concert.
